

TRANSCRIPT OF AN INTERVIEW HELD AT BARNET POLICE STATION ON
MONDAY, 15TH SEPTEMBER 2014.

TAPE 1 OF A BATCH OF 1

PERSON BEING INTERVIEWED: MR RICKY DEARMAN

PERSONS PRESENT:

DC SAVAGE	-	CHILD ABUSE INVESTIGATION TEAM
MS WATTS	-	LEGAL REPRESENTATIVE

DC SAVAGE: This tape is being tape-recorded, my name is Carl Savage. I'm a Detective Constable working on Barnet CAIT, that's Barnet Child Abuse Investigation Team, and there's no other police officer present. The person I'm interviewing, full name and date of birth please?

R DEARMAN: It's Ricky Dearman.

DC SAVAGE: Yeah.

R DEARMAN: And date of birth 20/12/69.

DC SAVAGE: Cheers, sir, thank you very much. And sorry, your legal representative is?

C WATTS: Catherine(?) Watts from [Inaudible] Solicitors.

DC SAVAGE: Cheers. Thank you very much. The date is Monday, 15th September 2014. Ricky, you've come into the police station today of your own free will?

R DEARMAN: Yeah.

DC SAVAGE:

You're not under arrest, and I keep saying this quite a few times. You're not under arrest but whilst you're at the police station you have two main rights. And one of rights is you have the right to free and independent legal advice and you can speak to a solicitor any time, day or night and this legal advice is totally free. Obviously you've come with your legal representative, if you need any more time to speak to her, just tell me, I'll stop the tapes and I'll leave the room. If need be I'll go into the next room so I can't hear what's being said. Okay.

Also, sir, whilst you're at the police station because you're going to speak to a police officer I have to read out the caution, but I want to say again you are not under arrest and are free to leave today if you wish.

R DEARMAN:

Yes.

DC SAVAGE:

Okay, so the caution is, you do not have to say anything but it may harm your defence if you do not mention when questioned something which you later rely on in Court. Anything you do say may be given in evidence.

I'm quite sure, sir, you understand what that means, but I'm just going to explain it to you because I do that for everybody. Okay so, so basically the caution is you do not have to say anything. This is your interview, if you chose not to speak to me, sir, don't worry it's not whether I'm happy or not, happy about it, that

is your right in law, okay sir. However, sir, if this went to Court and you come out with an explanation at Court, they may feel that you basically had time to think of something, make something up, for want of a better word, a story.

R DEARMAN:

Sure.

DC SAVAGE:

Okay sir, so that's the second bit of the caution, anything you do say may be given and, obviously, anything you do say may be given in evidence. It's all being tape-recorded, I am going to make some notes just to refresh my memory for our reports upstairs.

R DEARMAN:

Yeah.

DC SAVAGE:

But obviously the bulk of the interview is what's on these tapes, okay? We can go as long as you need, sir, you've got a pile of tapes behind you so you can take as long as you need just to get your side across. Obviously before we started, sir, and in front of your legal representative I did sort of say I know you have a lot to tell me, I've been told by one of my colleagues, but I just want to concentrate on the incident which your son has spoke to us about.

R DEARMAN:

Yes.

DC SAVAGE:

Get that dealt with, and then we'll go onto something else.

R DEARMAN:

Okay.

DC SAVAGE:

Okay, sir, thank you' for that, sir. So basically, sir, and your son, Gabriel-

R DEARMAN: Yes.

DC SAVAGE: He made a disclosure to police on the 11/09/2014 which was last week, in a Police ABE, and he made a disclosure to DC Martin. I was taking notes, that's why I'm interviewing you, I do know a little bit about it. I know your solicitor would've explained the disclosure, can you tell me what you know about what's been said?

R DEARMAN: Okay, I don't know anything about the actual occurrence that's what, which is just obviously my point of view, but during, there's several points I want to make based on this text from Gabriel. And first thing is the dates of this occurrence-

DC SAVAGE: Yeah.

R DEARMAN: -which has been from November 2013, I think it is?

DC SAVAGE: Yes.

R DEARMAN: To July 2014.

DC SAVAGE: Yeah.

R DEARMAN: Okay I, up until May I hadn't seen my children for about two years. Okay, so November, December, January, February, March, April, May. When I saw them in May was done so under supervision with Social Services, and the representative I guess can you use that word for Social Services?

C WATTS: Yes.

R DEARMAN: His name was Richie, and this was a request of me wanting to see my children again, because I

want to stick to this. So based on past issues with my ex and myself, so I saw them under supervision, I, gave me a great report, 'The children love him', of course they do 'cause I'm their father.

DC SAVAGE: Yeah.

R DEARMAN: And then we went to Court, you're going to have to excuse me on exact dates, but I do have a Court order with me, if you just want to check.

DC SAVAGE: Thank you.

R DEARMAN: I think it was the 16th June or the 19th June, actually, we went to Court. And the Court based on this Social Services report for me to start to have contact again with the children. That is every two weeks.

DC SAVAGE: Yeah.

R DEARMAN: For four hours.

DC SAVAGE: Yeah.

R DEARMAN: With the children, and then see how that goes and then we'll extend that to eight hours and overnight stay, etc., etc. Okay so, so the first time based on the Court order for the children and myself to meet up, and for me to be with them, I didn't turn up because, and it's the first time I've ever done that ever, in any Court order. I actually got the dates mixed up, I thought it was two weeks' time that it was going to happen. I would not have done that on my kids. So the second time which was the 05/08 I think it is, no, July, 5th of July I think it was. I picked the children about 2.40, instead

of two o'clock 'cause my ex turned up late, and so we went. Now she knew, okay, she knew and also Social Services knew that I was going to take my children swimming. Yeah okay, the reason that venue was I'd sent her solicitor-

DC SAVAGE:

Yeah.

R DEARMAN:

-emails, I'd sent her text messages and emails saying, 'I'm going to take them swimming, can you bring their swimming costumes?'

DC SAVAGE:

Yeah.

R DEARMAN:

She didn't reply, she never does. So Richie, Social Services, I spoke with him about this and he said, 'Well just go and buy stuff'. Well I'm short of money at the moment 'cause I was burgled in Belsize Park, police were involved and stuff, [inaudible] new business. They come to [inaudible], my business just went flat, okay. So I'm short on money a little bit at the moment, so anyway I said, I said to Richie, 'I've already done it, I've got them'. So I bought them new swim costumes for them both. We went to, and it's on the 406, to a swimming baths that we always go to, or we've always been to in the past, and there's a big cinema duplex, it's like a duplex thing, I can't remember the name. It might come under, I'm not sure, East Finchley. I'm not a 100%, but I can get the name of, it's a leisure centre like a council owned, you know.

DC SAVAGE:

I think I know what you mean, sir, yeah.

R DEARMAN:

Oh you do, there's a McDonald's and stuff there.

Yeah, okay, so we went there. Now we got there about three o'clock, 3.25-ish and I'm hoping that these guys have got CCTV there, which would have either been the 5th July 2014. So we went swimming and I bought a ball from, a rugby ball and a football, sponge ones from Sports Direct when I got their costumes. We love to play catch in the swimming baths, we had them both there, both, but we just took the football. Now we went and got changed, all three of us, together in the same cubicle, which is obviously important, okay. And so we got changed and then we went swimming. Now when we went swimming they have a machine that pushes the waves around every half an hour, it's on a timer. So when we were there it wasn't working, so what we was doing was we were playing football, you know, hit the person and then Gabriel would be jumping on my back, Alisa would be on my back, I'd be chasing, you know, just having, kids and, you know, son and daughter and papa fun.

DC SAVAGE:

Yeah.

R DEARMAN:

As you do, and Gabriel was cold during our swimming thing, and so we didn't actually spend long at the swim baths, an hour in the baths maximum, okay. Now during that time though we went to the toilet.

DC SAVAGE:

Yeah.

R DEARMAN:

Okay but, and so now I never leave the kids. I never will take Alisa, and Gabriel stay there or vice-versa. I never leave the kids by

themselves ever, ever in any time, any situation we go as a group. So we went to toilet, Alisa went to the ladies, I went in the gents. Now I went in the gents with Gabriel, he went into the toilet, and, I mean we've got swimming costumes on, you know. So, and there's guys taking a leak, you know, in the toilet and Gabriel went in, I came back out and wait for Gabriel. He came out, Alisa came out, we went back swimming.

DC SAVAGE:

Yeah.

R DEARMAN:

Then, he was shivering so I said, 'Do you want to go? We'll go to-', I can't remember the name, we went to a place, no, but before that, be specific. We go back into the changing room, 'cause this is important, we go back into the changing room all three of us together, and we got changed together. Alisa was never out of the room, Gabriel was never out the room, we were always together, together always. Then so we got changed and we went to the car. Now on that day before we actually went swimming I'd bought them presents, okay. And I've got the receipts for these, and I got them both a pair I think of Ralph Lauren jeans for them. I got Alisa a nice blue dress 'cause I ain't seen them for 10 months, and over 10 months, and Ella wouldn't let me speak to them on their birthdays, at Christmas, she just won't. And we'll go into this why after we cover this. So they had presents and I think we opened presents before we went into swimming baths. Okay.

So when we went to, bubbles, you know these big tubes that you get, swords, the big giant bubbles, and some over presents for them. So after we went to Brent Cross Shopping Centre, okay. Now in Brent Cross Shopping Centre there's a kids, 'cause we go there, 'cause I hadn't seen them for, actually I ain't seen them for two years actually up until this point. There's a kids' indoor playground thing where they go through the tunnels and stuff, you know, with these little balls and stuff. I've forgotten the name of the thing, but I have an account from several years ago there, so we went there about five o'clock-ish, okay.

Now what happened was they weren't allowing any more people in, they had a private party, okay, so they'd stopped I think five. It closes at six or something but they won't allow anyone in after five. So we couldn't go in, and there was, you know they were getting people out so that this private party could happen. So we went into the car park with other cars all around us and we ate, all three of us, we ate, I got some juice, fresh juice 'cause I'm vegan. So I had grapes, I bought some strawberries but they actually bought strawberries with them as well, you know, just remembering the events and so. Oh then so we sat down, oh, they had Hula-Hoops as well 'cause Ella always complains when I buy them, about Hula-Hoops, so they had a bag of Hula-Hoops each. And then we sat in the

car, doors open, having juice and stuff, and then, and I was just talking to them saying, 'How's school, what you been up to?', you know, just catching up. From there we went, 'cause we was on a time that usually I have to be back by six, I'm saying usually 'cause that was my first time seeing them. We should be back at six but I think it was seven o'clock because she was like 40 minutes late, 45 minutes late. Now the thing is everything is starting to close down at this time, okay, so what we ended up doing is from Brent Cross, opposite Brent Cross you have a new Costa Coffee. Okay, I don't know if you know it, there's a TK Maxx, JB, Next, Mama's & Papa's, thingy, a sofa place, Sports Direct inside this complex, bank opposite, on the other side of the 406[?]. So we went and had coffee, the kids had, the kids had, 'cause I gave them £10 each.

DC SAVAGE:

Yeah.

R DEARMAN:

Okay, so that's spending money, so I said 'I'll give you £10 each spending money for each time that I see you', every two weeks, that's like £5 a week. So they bought, I'm laughing 'cause they bought a mango-orange Frappuccino thing.

DC SAVAGE:

Okay, yeah.

R DEARMAN:

They had one each and they had a medium size, they wanted large and the ones in Costa Coffee cost like £3.25. And they wanted me to pay for it, and I said, 'No, you're getting it out of your own money'. And so they paid for it and

then they got their change and I said 'See, you've got to start to understand, you know, value and stuff'. And so we sat down in Costa and we had the drink and they had their drinks and then from there we went back to O2. Sorry, the pickup and drop off is the O2 shopping centre on Finchley Road. So then after I dropped them back there.

DC SAVAGE: Okay.

R DEARMAN: So that's the first time, okay. The second time I saw them, this is two weeks after.

DC SAVAGE: Yeah.

R DEARMAN: We went on the tube, and we went down into Central London and we went on the River Thames, on the boat. Okay, so we went up and down the Thames, we come back went, no before we went on the boat we went into Holland and Barrett, and bought some dried fruit mango, dried mango, bags of, it's like, you know, it's mango, it's mango. So then mango, some Hula-Hoops, and so they took them on the boat on the Thames. So we went on the boat, it's a beautiful day so we're upstairs, you know, and we were late by, we were late, this is the third time I've been late in five years, we were late. We got to Leicester Square tube station because the tube station further down, I'm not sure what was going on but they were closed. Certain tubes, I don't know why it was closed. So when we went on Leicester Square we had to queue inside for like 10/15 minutes. When we were walking down it was just

chocker block, so you know, all the way down the stairs, you know. So it was roasting, so we were down there for a good 15/20 minutes amongst hundreds, I mean it was packed this place and I don't know why. So this made us late 'cause we were having to walk from one tube then to another one trying to find a tube station that was open. Ah, that was the one that was closed, the Embankment, when we got off the ship, off the ship? When we got off the boat, we walked across the bridge from the London Eye side across the river, and then you've got Embankment that is closed. So that was closed so we walked up to Leicester Square and it was packed. And so we was in there for 15/20 minutes and then that's why we were late. We were about 50 minutes, maybe an hour late, which again it's the third time I've been late in five years. And I've got a text message to say that we're late, we're running late, etc. And that was 5th of July, two weeks, that was from, and the Costa.

DC SAVAGE:

Yeah.

R DEARMAN:

Two weeks after was in the Central London, I had not seen him or even spoke to them since the 12th July. I can show you on here.

DC SAVAGE:

It's okay, sir.

R DEARMAN:

On my Skype, and I haven't seen them since because Ella has every single Court order that's been put in place she's breached.

DC SAVAGE:

Okay, okay, sir, thank you for that, sir. What

I'm going to do, sir-

R DEARMAN: So any questions you have-

DC SAVAGE: I'll just concentrate on this bit, sir, then I know we need to talk about some of the other bits and bobs. So I'm going to ask you some questions, sir?

R DEARMAN: Sure.

DC SAVAGE: I think it's going to be the easiest thing to deal with, so you do say you went swimming but that was obviously after the Court order and that was on the 5th of July.

R DEARMAN: Yes.

DC SAVAGE: And you went to East Finchley, one in the multi-complex.

R DEARMAN: Yes.

DC SAVAGE: Okay, so when all three of you got changed together, whereabouts was that?

R DEARMAN: Yeah, I can tell you, if you go, you do payment, go through, it has a turn style, go through the turn style, go right and what it is, it's like a, not open-plan but you've got, when you go around the corner you've got like a little shop in the corner, you turn right and you have like three or four showers, four or five showers here. And then you have the lockers where you put your things in and then there's cubicles here. And we were in, can I draw you?

DC SAVAGE: Yeah, fine.

R DEARMAN: So, payment desk here, front door here, yeah. So you come here, you go, payment here.

DC SAVAGE: Yeah.

R DEARMAN: And then turn style is there, so I'll put a tune style, turn style is here, we go through. You go right, there's a shop here.

DC SAVAGE: Yeah.

R DEARMAN: And a door here, the pool is here, the pool is here, and there's another pool actually here, this is the front one and this is the proper kind of for more serious, you know, up and down lengths. So turn right and then you got the shop here, and then you've got some changing things here, and then you go here into this space here, sorry, it's actually like that actually. Then what you have is you have, these are changing here, changing rooms. Your pen's, okay.

DC SAVAGE: Yeah, the pens going to run out.

R DEARMAN: Okay I've got one.

DC SAVAGE: You can just explain it.

R DEARMAN: Then you have showers here, four, and you've got a changing room here, changing room here, changing room here. These changing rooms you see here, not these ones, these are like three or four changing rooms here, and then you've got your lockers, lockers, this area here is locker and locker.

DC SAVAGE: Thank you.

R DEARMAN: So you've got lockers here.

DC SAVAGE: Yeah.

R DEARMAN: Lockers are here, and you've got lockers here. Okay and here, here, you see the thing with these here, these, these changing rooms it was

this one here. Now these changing rooms are bigger.

DC SAVAGE: Yeah.

R DEARMAN: Than these ones here, so that's why, these ones.

DC SAVAGE: Okay, and why choose a big one, sir?

R DEARMAN: Because there's three of us.

DC SAVAGE: Yeah, fine.

R DEARMAN: Yeah.

DC SAVAGE: Okay sir, thank you for that. Can I just, thank you.

C WATTS: Yeah, no problem.

DC SAVAGE: The bigger ones, were they for anybody in particular?

R DEARMAN: Anyone.

DC SAVAGE: So anyone can use them?

R DEARMAN: Yeah, and there's families in all of them, that's why I went there as well.

DC SAVAGE: Was there anything else inside these changing rooms, obviously you've got changing rooms, you three, what else is inside?

R DEARMAN: Yeah, here, on this wall here, yeah, is a baby changer.

DC SAVAGE: Yeah, okay.

R DEARMAN: And basically what I do is, you know, 'cause I'm quite tidy as a person so I lay out our clothes there and towels, I don't like them standing on the floor on the wet, so I use, kind of old towel for them to stand on and a new one to get dried on.

DC SAVAGE: So there's a baby changer there, anything else in the room, sir?

R DEARMAN: No, nothing at all, nothing. No, no, bench.
DC SAVAGE: There's a bench.
R DEARMAN: I've even got a photo, I may have even got a photo.
DC SAVAGE: Okay, sir.
R DEARMAN: Can I show you?
DC SAVAGE: If you've got a photo, sir.
R DEARMAN: I think I have a photo or I might have put it on here.
DC SAVAGE: Don't worry, sir, we'll get it in a minute.
R DEARMAN: I might have even got it in, I have a photo of them in the changing room.
DC SAVAGE: Cheers, sir.
R DEARMAN: Together.
DC SAVAGE: Okay, so you obviously know what your son has disclosed, sir.
R DEARMAN: Yeah.
DC SAVAGE: Would there be any reason why you would need to touch his backside whilst throughout the changing, you know?
R DEARMAN: None at all.
DC SAVAGE: Okay, sir.
R DEARMAN: In fact, I didn't even dry them.
DC SAVAGE: Okay.
R DEARMAN: They are eight and nine, they dry themselves.
DC SAVAGE: Whilst they were in your care did your ex-wife?
R DEARMAN: My ex-girlfriend.
DC SAVAGE: Ex-girlfriend.
R DEARMAN: Sorry yeah, we live together [inaudible].
DC SAVAGE: Sorry.
R DEARMAN: No, it's okay.

DC SAVAGE: [Inaudible]. So your ex-girlfriend did she sort of say, 'Gabriel he needs like Sudocreme on his backside', or some sort of, something like that?

R DEARMAN: No, no nothing. Absolutely nothing.

DC SAVAGE: No, okay. So no-

R DEARMAN: Absolute, doesn't make any sense at all.

DC SAVAGE: No okay, sir. Now I know-

R DEARMAN: No talc, no nothing. Oh I tell you what I may have, okay, I may have, but this is what I may have done is I have expensive, quite expensive oils.

DC SAVAGE: Okay.

R DEARMAN: Aftershave.

DC SAVAGE: Aftershave, yeah.

R DEARMAN: Once we're dressed, okay, what I do I put a bit behind I put a bit here, and I go like that and then they do that.

DC SAVAGE: Yeah, so you're rubbing it together on your wrists.

R DEARMAN: I'm just saying regarding any application, I'm just being really specific here, I spray on their wrist and then they put that. May have happened that day 'cause I used it, you know.

DC SAVAGE: But you're saying there's no reason why, you didn't touch your son's backside.

R DEARMAN: Not at all.

DC SAVAGE: In any way, okay. Also, sir-

R DEARMAN: Oh and I might have, sorry to interrupt you, I may have put or gave them, and I can show you it's in the car. Both of them put, maybe, and this is just maybe, I need to think back, give

them wax.

DC SAVAGE:

Wax.

R DEARMAN:

Yeah hair wax.

DC SAVAGE:

Oh hair wax, that's okay hair wax, okay. Okay Sir, I'll just move onto the next question and as a father it could be quite upsetting for you, but we're just going non what we've been told, sir. So at any stage did you insert anything into your son's backside?

R DEARMAN:

No.

DC SAVAGE:

Did you ever insert, have you very inserted anything into your son's backside?

R DEARMAN:

No. No.

DC SAVAGE:

Okay, sir. But you do confirm that you were, did go to East Finchley swimming baths and you say on that day, you know, it was after getting the Court orders and everything sorted out. You picked them up, they did open presents beforehand, you also gave him like a bubble machine that bubbles, and taken them swimming.

R DEARMAN:

Not a machine, it's just a hand one.

DC SAVAGE:

Oh Pardon, thank you, sir. Yeah, a hand machine. You've gone into the swimming baths, you've gone to the changing rooms, which is, you've chose a big one 'cause you've got two children with you.

R DEARMAN:

All of these are big ones.

DC SAVAGE:

Oh so all of these are big ones.

R DEARMAN:

And that's where the first one is available 'cause all of the others were full, do you know, it's busy.

DC SAVAGE: But what you're saying is 'cause you've got two children with you, you needed a big one.

R DEARMAN: Absolutely.

DC SAVAGE: Okay.

R DEARMAN: 'Cause these ones here are smaller than these four here.

DC SAVAGE: Okay, sir, thank you. And you said inside the changing room there's just like a baby changer?

R DEARMAN: And a seat.

DC SAVAGE: And a seat and you used the baby changer to sort the clothes out.

R DEARMAN: That's right.

DC SAVAGE: Nice, neat and tidy, and rightfully so when you've got children. Okay, sir. My last question on this subject literally is, why do you think your son is saying this?

R DEARMAN: There's only, 'cause this is so, you know, out there.

DC SAVAGE: Yeah.

R DEARMAN: There's only one thing that I can, actually two things that can come to mind why.

DC SAVAGE: Yeah.

R DEARMAN: One is, are they referring to me?

DC SAVAGE: Yeah.

R DEARMAN: And the reason I say that is, usually when they speak to me I've got videos of every single Skype conversation that we've had. When they speak to myself it's usually as 'papa', not 'father', okay. Now maybe 10% of the time Gabriel will call me 'Ricky' and not 'papa' or 'dad', and Ella allows that 'cause she enjoys it

on some level, because of, she's tried to distance the children from me as you can see in the Cafcass reports. You can see that she's, the Cafcass have got a warning that she's told the kids certain things, putting ideas in their head, telling them certain things that are going on. I'm hitting her, etc., and so she's had, they were worried, or they had a concern about this. It's on one of the reports I have from Cafcass. So either they, he, not they but he, Gabriel, is either talking about, because of the timeframes and so on, about Ella's boyfriend, because they live together.

DC SAVAGE:

Yeah.

R DEARMAN:

And 'cause they're calling him, and they call my father, I don't know, I don't know how they address him.

DC SAVAGE:

Okay.

R DEARMAN:

Okay, that's one thing, I don't know this guy I've only seen him I think two three times on pickups and drop offs, on these two occasions. Two is Ella is a sick women.

DC SAVAGE:

Yeah.

R DEARMAN:

And has done anything and everything to have the police arrest me, sexual harassment, she'd try to do me. The reason I have not seen the children since last July and I had to go back to Court, and I can show you, okay, one sentence on here of she said that I sexual harassed her in front of the children on Skype. The day that she said that occurred the children were in

school, on a Friday, okay. And they chat and the conversation wasn't actually had it was a chat, a chat chat, not a talking conversation chat. I have it here, okay, of a sentence and based on this sentence I, basically I'm a marketer, okay, at the moment, I'm doing Internet marketing. And one of, I don't know if you know this, but everything that we all buy online is done so because of the porn industry.

DC SAVAGE: Okay.

R DEARMAN: There's a movie about it, it's hilarious. It really is a funny movie, anyway and the reason that is they are the smartest marketers in the world, do you mind if I explain this?

DC SAVAGE: Yeah.

R DEARMAN: How they have actually, they have moved and progressed things forward. When I was searching online on the Internet for myself or when I'm doing media rights, I have tools, okay, that will go out and grab software, it's not mine, you go on it's called, and basically, I'll think of the name. And what it does it will go and get, for example, I'm launching this week a new weight loss course, when I got burgled. When I'm doing media buy, what I do is, 90% of success online is research, okay. So I can go with this software, it's legal, it's all legal, I can go and I can for weight loss or any niche 'cause I do this as consulting companies as well.

DC SAVAGE: Yeah.

R DEARMAN:

I can go and get, for example, weight loss is the niche now I'm doing now, I can go and find all the major players using banners for weight loss. So what I can do, or whoever has these tools, I can go to find out exactly where their banners are all over the internet. And if a banner, if a banner is there for three days and there's a banner over here for 91 days this banner's working. People aren't going to pay for something for three days, they've took it off, based on the style and the design, 'cause there's a whole science behind marketing on a 200 by 250 banner. I don't want to bore you.

DC SAVAGE:

No, no it's fine.

R DEARMAN:

And then, and also where it goes on a certain website, Yahoo, AOL, etc, etc. Google made thousands of different websites, so I can go directly where these banners are the longest. So I can go into the industry knowing that I'm going to go in without spending money or losing money and start making money quicker. Okay, now in that process of that you can get banners from the porn site, from this site, it will pull back, okay, all the banners. Now from a marketing perspective anyone who knows anything online from a direct response to that style of marketing is the porn industry are the top of the game in how they do stuff. They've always, the way they code stuff, everything. I'm not an expert with it, and so part of research is, say it's out of 100 websites, I will, they'll be one

to do with porn but I will look at their banners and what they're doing, okay. Now on this, during my research which I do all the time, all the time with these two. I, and this is Gospel, okay, I can show you the text messages and this is Skype with Ella, I thought that I saw Ella on one of the porn sites.

DC SAVAGE: Okay, yeah.

R DEARMAN: Okay. I am 90, 90/95% it was her, okay and may I show you?

DC SAVAGE: Yeah, yeah.

R DEARMAN: I'll show you the chat, okay. Oh I might have to do it on here, sorry, I might have to do it on here because this goes back further.

DC SAVAGE: Okay.

R DEARMAN: Okay, that's just from Friday, 'What's going on Ella?', the children are in care and she's not responding to that. So let me just go, you're more than welcome to go through all of this. See they called my dad, Alisa did, usually, 90% they call my papa.

DC SAVAGE: Yeah.

R DEARMAN: I've got video's showing that, you know. So, [inaudible], okay, okay. Which I'm going to show this in Court on the 30th 'cause I went a year based on one line. I said, 'Ella did you check that video out?', and she said 'It's not me, that's not me, it's in your head'. Right, I'm going to show you I said, okay, that is it, and she went to, and this is the thing, she went to the police, I'm going to show you the date

the police checked, she went to the police on sexual, based on that one thing, for sexual harassment.

DC SAVAGE: Okay.

R DEARMAN: Two months after.

DC SAVAGE: Okay and what did the police do about it briefly?

R DEARMAN: They phoned, they were trying to phone me, okay so I phoned them, I had a conversation, right based on the phone, and he said, 'No problem'. I explained exactly, I said, 'If you want me to come in, I can show you it, I can promise'. He said, 'Just don't phone her', I said, 'fine'.

DC SAVAGE: Okay, all right.

R DEARMAN: But I'm going to show you that this sexual harassment took my 10 months to get back in Court to see my kids again because she's lied again.

DC SAVAGE: Okay, so she's basically said this, stopped you seeing your children.

R DEARMAN: Exactly.

DC SAVAGE: And you've been fighting ever since.

R DEARMAN: Yeah, and I'm going to show, I'm going to show you, because it is here. Okay, audio, okay, two, okay, 'Also two things, that audio book that I sent you used to do some Dr Wayne diet, it's a doctor, I don't know if you know him he's a philosopher, anyway it's good stuff. Anyway it's very good, it's really good. It's proper. Did you check that video of yourself that I mentioned of you on the adult site?'

Oh, because, because, sorry, because what happened a year before this, okay, she got in touch with me about a year before and said that some guy who she was dating, had put some porn of her on the website. And I said, 'Well what you telling me for, you've got to speak-', I don't know who this guy is, I mean the communication between Ella and myself is so toxic.

DC SAVAGE:

Yeah.

R DEARMAN:

She's a nuclear, and you can look at the Cafcass reports on this. Our paperwork is this high, I bullshit you not, it's like that. I've had five years of this.

DC SAVAGE:

Yeah.

R DEARMAN:

In this one, in this not one piece of evidence put me guilty of anything.

DC SAVAGE:

Okay.

R DEARMAN:

Nothing, so let me, so 'Did you check out that video of yourself? I think that it's on a few of the sites', because there's a link that leads away. Okay this is on July 5th, you see that, 'cause when I move this up and down, that's now 4th, so that's July 5th, which is a Friday. Okay, Friday, so it's 2013 okay.

DC SAVAGE:

Yeah.

R DEARMAN:

'I understand that this is the way you feel' okay, because I wanted to speak to the children.

DC SAVAGE:

Yeah, yeah, yeah.

R DEARMAN:

Okay. And again, no, I wanted to pick them up from school, she said, 'So, but it's not the

right way to go about it, today children have a long day so we'll see how', because she just keeps stopping all the time any, in every way she can. 'Tomorrow is a more relaxed day and perhaps better to speak to them, let's take it from there, and what's your availability like?'. And I said 'Okay, let's speak tomorrow?', Sunday I will be meditating, because I meditate.

DC SAVAGE: Yeah, yeah, yeah.

R DEARMAN: And on the first month, oh yeah, 'I would like it to be a surprise for them so don't say anything, a Skype to Skype on Saturday should be okay. Sunday I'll let you know'. 'There is no room for surprises', 'cause I wanted to go to school and surprise them.

DC SAVAGE: Yeah.

R DEARMAN: Okay further up I can show you, so 'To clarify, to clarify Skype tomorrow', 'cause she's always either late or 90% doesn't happen, even if there's a Court order in place. She's breached every Court order in five years, every one. So, okay here, so I've not said anything from 5th July about, it's on a few other sites that link away, okay. So 5th July, 'Okay I understand', that's her reply to that about meeting on what you call it. 'Nobody put any footage of me on any adult site before, that's your imagination. If it goes to your reference to, nobody has footage of me unless you've retained without my consent. I'm not going to adult sites anyway wherever, it must be someone else. I'm

incredibly busy at the moment and unlikely to check the video, videos you want to show, thank you. Okay, I said, 'Okay, no problem, firstly I wouldn't do that, I wouldn't put something like, and second you must have a double then', end of story, okay. Now it's still the 5th, okay, 'Okay there are videos, audios, and not video', now this is coming, okay, this is not, this is totally separate, this is to date, I'll show you what I sent her, Doctor Wayne Diet, he's a philosopher, okay, excuse me. Because she said, sorry, let me explain. Oh yeah she said, oh yeah that's right, 'I'm incredibly busy at the moment unlikely to check the videos, they're audio's I wanted to look at'.

DC SAVAGE: Yeah, yeah.

R DEARMAN: This is something totally separate now, this is a different conversation. I can show you, I tried to send her flowers over and I even replied, 'They're not, they are audio's not video's by the way'. And so this is to do with Doctor Wayne Diet, okay. That is it, that is all that happened. Then I get a phone call from the police two months after this incident.

DC SAVAGE: Yeah.

R DEARMAN: To say that I've been sexually harassing her, I then I have to go another year almost to see my kids. This is what she keeps doing, you can see Cafcass reports, she does whatever she wants anytime she wants. She's been caught out lying before that, okay, so then but, so now 6th of

July, okay, see it starts where I move that up it's going to change to the 6th, watch, 6th. So now, so now 5.50, 'Hi Ella I'll be another 50, 45, 60 minutes'. 'Hi Angel, papa will be with you', see I called myself 'papa', which referencing to father is worth looking at, okay. Just, so then I called, no answer. Okay, she says 'five minutes', I said 'Okay'. So call, no answer, call, no answer, now this is on the 6th of July which is a Saturday. If you look at the times on here I will show you, every, and this is throughout whatever, I can show you a video 'cause she said that she did this in front of the children. That sexual harassment where I was harassing her in front of the children, I can show you and link and give you a video linking to this exact second and time of date of conversation that happened between Alisa, Gabriel, and myself.

DC SAVAGE: Okay.

R DEARMAN: Every single time.

DC SAVAGE: Okay alright, okay, sir. What I'm going to do, Ricky, 'cause I don't want to completely go through all your Skype with her and anything like that. What I'm going to try and do in a minute and at the end we'll speak, I'll speak with your solicitor as well, 'cause I want to do something slightly different, but in a complete bundle 'cause obviously I'm aware of the time and everything.

R DEARMAN: Yes.

DC SAVAGE: Are we saying, and correct me if I'm wrong and please interrupt if you need to, basically that this is all made up and that you're feeling that it's all either powered by your wife or her boyfriend?

R DEARMAN: No, no, I'm not saying that.

DC SAVAGE: So what are you saying then?

R DEARMAN: I'm not saying it's powered by her boyfriend, I'm saying are they talking, were they talking, were they addressing me.

DC SAVAGE: Yeah.

R DEARMAN: As father or do they call him father. I don't know 'cause I don't know how many months or years they've been together.

DC SAVAGE: Right I'll stop you there with that one, they were saying 'dad'.

R DEARMAN: Dad.

DC SAVAGE: They're saying 'dad' all the time.

R DEARMAN: They do call me 'dad', they do call me 'dad'.

DC SAVAGE: Yeah, so they were saying 'dad' when I did the thing.

R DEARMAN: 10% of the time though.

DC SAVAGE: But, yeah, you have said, you know, it's 'papa' usually, 10% 'Ricky', but now and then 'dad'.

R DEARMAN: Now also this is important to know as well, very important to know, in five years of, you know, argy bargy with Ella I have, me being with the kids once I've told my kids off.

DC SAVAGE: Yeah.

R DEARMAN: Once in five years, and what happened was they were fighting in the back of the car.

DC SAVAGE: Yeah.

R DEARMAN: So what I did, this is really important because of what, so they were fighting with each other in the back of the car. Me, is all about they have to respect and love each other, they have to treat each other with kindness, you know, food they have to share, if they want to, not always. But you know I have tried to install good natured behaviour, so they were fighting, so I stopped the car, pulled over, got them out the car to give them time out, stood them against the wall and I said, 'Guys', and I shouted at them, okay, I shouted at them. It's the only time I've done that ever, okay, because each time I would pick them up their behaviour-

Tape Buzzer.

DC SAVAGE: We've only got a minute left then I'll change tapes.

R DEARMAN: Their behaviour was getting more and more erratic, okay, every time I saw them, 'cause I was just with them at the time once a week. Their behaviour was getting more and more erratic, now Ella said that when they leave me they start fighting each other and fighting strangers, and kicking strangers in the street. Okay, it's not true I would film pickups and drop offs and always content and happy, always. Cafcass have seen this video, this is why Cafcass started, I think one of the reasons why Cafcass started to say that, I forgot the term they used, but not a warning they had a warning

but a concern that the mum's telling the kids stuff. Okay, so what happened was Ella went and told Cafcass and the Courts that I had got the children, and then stuck them on a 10, 15 foot wall and sat them up there for bad behaviour and I left them there.

DC SAVAGE:

Yeah.

R DEARMAN:

Okay, it's just insane, you just won't do anything so stupid. Now I have on a Skype call, of a recent one that Alisa and Gabriel actually believe that I did that and I said, 'Guys, when? I didn't put you on a wall, why would I put you guys on a wall?'

DC SAVAGE:

Who do you think has made them believe that?

R DEARMAN:

Ella, only Ella. There's just no way, it's just not my thing, it's just not what I do.

DC SAVAGE:

Okay.

R DEARMAN:

I can promise you...

DC SAVAGE: This interview is being tape-recorded; it's the second tape now, of the same interview of Ricky Dearman. The last tape would've stopped about 17:08, the time now is 17:10. Ricky, I just want to confirm that we haven't spoke about anything-

R DEARMAN: No.

DC SAVAGE: -while the tapes were-

R DEARMAN: No.

DC SAVAGE: No.

R DEARMAN: No problem, no, nothing.

DC SAVAGE: No, okay and you're happy to continue?

R DEARMAN: I am.

DC SAVAGE: Okay and just obviously your rights all-

R DEARMAN: Yeah.

DC SAVAGE: -remain. You're not under arrest, obviously I've given you the caution when we started

beforehand and if you need to speak to your solicitor again, please let me know-

R DEARMAN: Okay.

DC SAVAGE: Okay? So Ricky, over to you again.

R DEARMAN: Thank you. What's also very valid here and very important to, I think, what your question of why would I, why would anyone, if I haven't done it, say something like this. I have a, when I've, I've got several of them where Ella's telling the kids what to say to me, in the background.

DC SAVAGE: Okay.

R DEARMAN: Okay? So, what happened was the last one which again was a breach of the court order, ah, oh, do you need...? Okay. [Inaudible]. This is really, yeah with the kids and Ella, this is important, okay. Where she's in the background and you can hear her, I've got her on voice, on a call-

DC SAVAGE: Yeah.

R DEARMAN: -on, [inaudible] and also on Skype[?] where she's actually telling the kids what to say to me.

DC SAVAGE: Yeah.

R DEARMAN: Okay. Where she's influencing what they say and how they say things to me.

DC SAVAGE: Okay.

R DEARMAN: Okay? I have this as evidence, on audio and video.

DC SAVAGE: Right.

R DEARMAN: On several different occasions.

DC SAVAGE: Yeah.

R DEARMAN: Now, this is really important. This is weird for why, why now? Okay. What happened, the last time I was with the children, okay? The last time I was with the children, Gabriel and Alisa told me something, okay?

DC SAVAGE: Mm-hmm.

R DEARMAN: Sexually. Okay?

DC SAVAGE: Okay. So this is the trip [to them?] in London, in London was it?

R DEARMAN: Yeah, yeah. They told me something sexually about what was happening. Now, my mum knows about this and I was [going to?] speak about this in court on the 30th and the reason I haven't, and I can prove this by audio-

DC SAVAGE: Mm-hmm.

R DEARMAN: -why I haven't mentioned it to Social Services and I tell you why after I tell you what Gabriel and Alisa told me. I, when I first picked them up, first time, her ex was, sorry, Ella's partner was with them and he was very aggressive towards me and threatening-

DC SAVAGE: Yeah?

R DEARMAN: -just standing really close to me, just [inaudible] just staring at me, he just, in the book shop, in the book store. Very peculiar, okay. I didn't say anything and I just think that Ella's again, to try, I mean, I'll show you that she just does everything she can to try and rile me. Now, I, the second time I saw the kids, I said, ah, it's just this vibe from this guy-

DC SAVAGE: Mmm.

R DEARMAN: -okay? But hear me out okay?

DC SAVAGE: Mmm.

R DEARMAN: I know you are, I know you are, I, but what, I said to the kids, I said, 'Guys, you know, he's your, he's looking after you now'-

DC SAVAGE: Yeah.

R DEARMAN: -'With your mum'.

DC SAVAGE: Yeah.

R DEARMAN: Okay? 'If he hurts you-

DC SAVAGE: Mmm.

R DEARMAN: -in any way-

DC SAVAGE: Mmm.

R DEARMAN: -you have to let your school teacher know,-

DC SAVAGE: Yeah.

R DEARMAN: -me know'-

DC SAVAGE: Yeah.

R DEARMAN: -okay? 'You have to tell me if anything goes on with this guy', okay? 'If he's not loving towards you, if he hurts you' and Alisa told me that he pulled her hair. Now, she was ill one night and he went into her bedroom with a lemon and water drink and she was tired and half-asleep-

DC SAVAGE: Yeah.

R DEARMAN: -and she dropped the drink-

DC SAVAGE: Yeah.

R DEARMAN: -by accident because she was like, two or three, I don't know what time it was but it was early hours and so, he got her, he grabbed hold of hair and pulled her hair-

DC SAVAGE: Yeah?

R DEARMAN: -okay? And Gabriel said that he, he's done that on one or two occasions.

DC SAVAGE: Okay.

R DEARMAN: Okay? Then I said to them, I said, 'Guys, I will sort this out okay? You are not to be scared of this guy or anyone, me or anyone, nobody has the right, even Papa-

DC SAVAGE: Mmm.

R DEARMAN: -to hurt you. Nobody, okay?' And Gabriel then said to me, okay, and I know it's true because the way that he reacted, the way that he was embarrassed to tell me.

DC SAVAGE: Mm-hmm.

R DEARMAN: He walked into the bedroom and saw them having sex. Okay?

DC SAVAGE: Who, sorry, who-

R DEARMAN: Saw sex, yeah.

DC SAVAGE: -saw who?

R DEARMAN: Gabriel walked into the bedroom and saw his mum and this guy having sex.

DC SAVAGE: Yeah.

R DEARMAN: And Gabriel said, 'What are you doing with Mama?'

DC SAVAGE: Mmm.

R DEARMAN: And he laughed and said 'Nothing. Why?' And Gabriel said, 'You're doing something'-

DC SAVAGE: Mmm.

R DEARMAN: Okay? And he said, 'Well, I can do whatever I want' and he starts to play with Ellie's breasts.

DC SAVAGE: Okay.

R DEARMAN: Okay? And while Gabriel is telling me this, I'm pretty okay with reading people-

DC SAVAGE: Yeah.

R DEARMAN: Okay? And he went red-

DC SAVAGE: Yeah.

R DEARMAN: -when he told me. And I said, 'Gabriel, I'm really proud of you for telling me this because I know it might be difficult. I'm really proud you've told me this.

DC SAVAGE: Mm-hmm.

R DEARMAN: You've done nothing wrong here.

DC SAVAGE: Mmm.

R DEARMAN: In fact, Gabriel, you was in the right.

DC SAVAGE: Yeah.

R DEARMAN: Okay? And I know that's hard and I don't know if you can understand me because you're eight but you actually stood up to someone and told them that at eight years old and you knew-

DC SAVAGE: Yeah.

R DEARMAN: -he was wrong' and I said, 'I'm proud of you'.

DC SAVAGE: Mmm.

R DEARMAN: And this, Alisa and Gabriel were always together, and I said it to both of them and I said, 'If anybody, if he hurts you, if he hits you, I will sort this out, now'. Why have they not said this before? I have audios because I, do you know what? I've been through hell with this-

DC SAVAGE: Mmm.

R DEARMAN: -I did one on one with the, with the judge, two

weeks ago-

DC SAVAGE: Yeah.

R DEARMAN: -three weeks ago. In five years Ella's mentioned, I've not done one thing wrong.

DC SAVAGE: Mmm.

R DEARMAN: Nothing. I'm a good father, I'm a fantastic father. Okay?

DC SAVAGE: Yeah.

R DEARMAN: I said to the judge, 'Why is it that someone can go to court and say that I've done this and this and this?', because that's what happened.

DC SAVAGE: Yeah.

R DEARMAN: I left the relationship and I have to go a year, two years before I see my kids, to get back in court.

DC SAVAGE: Mm-hmm.

R DEARMAN: I'm guilty until proven innocent.

DC SAVAGE: Mmm.

R DEARMAN: I'm not innocent until proven guilty.

DC SAVAGE: Mmm.

R DEARMAN: And the judge said to me two or three weeks ago, 'You're right; the system is wrong. Outside of me being a judge now, I'm just talking to you one on one'.

DC SAVAGE: Yeah.

R DEARMAN: After, in five years it's still carrying on. Now, so why have you not said this, anything to you before? Meaning. So I've recorded as much as I can when she started to say I'm doing this because she got the child psychiatrist involved at, in, between Hampstead and St Johns, I can

find the exact, later. She said, that child psychiatrist has said that the children, it's not good for the children to see their Papa.

DC SAVAGE: Okay.

R DEARMAN: Okay? I went to see her, because no way-

DC SAVAGE: Mmm.

R DEARMAN: -she said, so I went to see the child psychiatrist and she said, 'I never said that'. So I got, straight away, jumped on the call to Cafcass, she got caught out lying again. Okay?

DC SAVAGE: Yeah.

R DEARMAN: So, the reason I tell you this, after saying, after she said I've done this and I've done this and I've done this and done this etc., and it's on and on and on and on. The file's this big -

DC SAVAGE: Yeah.

R DEARMAN: -I've won every single court case, every one. Every single one.

DC SAVAGE: Yeah.

R DEARMAN: Okay? So my point is this, and this is why I was saying to Matt[?] before, briefly, outside, but I'm pissed with Social Services.

DC SAVAGE: Mm-hmm.

R DEARMAN: One, because I feel like I've been treated like a criminal.

DC SAVAGE: Mmm.

R DEARMAN: Because I said to Yvonne, the manager, 'Can I see you on Tuesday?' She said, 'Why do you want to see me?' I said, 'What do you mean? My kids are being taken away, what do you mean, why do I want to see you?' She, and when I go through

show me this footage, she went, she said, 'I'll think about it'. You'll think about it? What response, I tell you, I don't, I feel like a criminal here.

DC SAVAGE:

Mmm.

R DEARMAN:

She'll think about it? I'm sorry, but that knocks me.

DC SAVAGE:

Mmm.

R DEARMAN:

And straight, you'll get exactly what I am, okay?

DC SAVAGE:

Mmm.

R DEARMAN:

And so, so what happened was this: I've got the audios, I've got it all recorded.

DC SAVAGE:

Yeah.

R DEARMAN:

Richie, who was the social worker on this case-

DC SAVAGE:

Yeah.

R DEARMAN:

-has now been taken off this case. He phoned me said, 'I'm off this case now, this is the number to [Chantelle Stevens?]' . So, I told Richie that she's breached the order on the video; she's telling the kids what to do, basically having adult conversation-

DC SAVAGE:

Yeah.

R DEARMAN:

-they said in court 'You're not allowed', [doing adult?] conversation and she's telling the kids that I'm not letting them go to Russia, they're not allowed to even go to Russia because we have no jurisdiction here to get them back.

DC SAVAGE:

Yeah.

R DEARMAN:

Ella's, and Ella's telling this is why she's [inaudible] saying, 'Papa needs to talk to you

about, it's serious, why can't you let us go to Russia?' and I said, and they've even said, I can show you the video, they're upset with me.

DC SAVAGE: Yeah, yeah.

R DEARMAN: Okay? I said 'Guys, I would love you to go but it's complicated' because they're not, we can't do nothing to get them back. The law, the courts won't allow Ella to go; she can go abroad but she can't go to Russia.

DC SAVAGE: Mmm.

R DEARMAN: She's telling the kids that, so they're turning on me.

DC SAVAGE: Mmm.

R DEARMAN: Okay? I've got it, I told Cafc..., I told Social Services, okay?

DC SAVAGE: Mmm.

R DEARMAN: Richie said, 'Ricky, I don't need to know' I said, 'Look, can I email you the file?'

DC SAVAGE: Yeah.

R DEARMAN: 'Ricky, nothing to do with me. I have no power, we have no power, take it to court'. She breaches, doesn't turn up. I tell him, 'Ricky, I've told you, go the court way, they got...' but I recorded this, okay? I tell him that he's, I, that the, had pulled her hair, had pulled Alisa, 'You need to take this to court'.

DC SAVAGE: Yeah.

R DEARMAN: So, he said, 'Don't tell me'; he was actually a bit narked with me because I'm on the phone all the time.

DC SAVAGE: Mmm.

R DEARMAN: Okay? Because they're my kids. I've never done any harm to them. I'm a good dad.

DC SAVAGE: Yeah.

R DEARMAN: I'm a really good Papa. And so, when this information come, okay, I can call my mum and say 'Mum, tell them about this experience now what I told you'-

DC SAVAGE: Mmm.

R DEARMAN: -and she'll tell you.

DC SAVAGE: Mmm.

R DEARMAN: Okay? And the reason I didn't mention it to, because every time I call him, 'I can't do nothing. We have no power, Ricky'.

DC SAVAGE: Mmm.

R DEARMAN: 'You have to put it down in your statement on the 30th, .

DC SAVAGE: Right.

R DEARMAN: And I can give you that recording-

DC SAVAGE: So-

R DEARMAN: -of him saying that to me, over and over and over because I ask him all the time, I'm on the phone with him all the time.

DC SAVAGE: Okay. Right, Ricky, so are we saying, you were saying, going back to my original question-

R DEARMAN: Yes.

DC SAVAGE: -was, this has all been fed in by your ex-girlfriend, yeah?

R DEARMAN: Yes.

DC SAVAGE: And you're saying that you feel that apart from the incident which your daughter spoke about, pulling the hair-

R DEARMAN: Yes.

DC SAVAGE: -and what Gabriel spoke about, seeing his mum have sex with the boyfriend and-

R DEARMAN: Yes, and he said that in front of Alisa as well.

DC SAVAGE: Yeah, is basically you do not feel that this boyfriend's got any involvement in what's happening to the children-

R DEARMAN: I have no idea-

DC SAVAGE: -what's been said.

R DEARMAN: -I don't know him. I have no idea and I will not comment, I won't say otherwise because I don't know.

DC SAVAGE: Okay. Alright. I know you've probably got a lot still on your plate; the only thing obviously, I'm interested in is the criminal matter, nothing, everything you've been telling me, I will be very honest with you, Ricky, is probably more for the Family Courts. I'm going to be very honest with you-

R DEARMAN: Yeah.

DC SAVAGE: -but thank you for that. I think maybe what the best course of action is-

R DEARMAN: Mm-hmm.

DC SAVAGE: -unless you've got anything else to add, we'll start wrapping up-

R DEARMAN: Mm-hmm.

DC SAVAGE: -and then once the tapes are finished, if my, I'll leave you guys to have a quick chat but then we'll get to DS Matt Fernandez-

R DEARMAN: Yeah.

DC SAVAGE: -and see if he can have a quick chat with you-

R DEARMAN: Yeah, yeah.

DC SAVAGE: -just to battle[?] some things out, because I'm going to be very honest with you: my, thank you for being very honest with me, but you have told me a lot of stuff that I personally feel is for the Family Court-

R DEARMAN: Yeah-

DC SAVAGE: You are giving me a hell of a lot of background information, which is good-

R DEARMAN: Yeah and-

DC SAVAGE: -but you need to tell me anything else [inaudible].

R DEARMAN: Would the Cafcass report, it's a question to yourself-

DC SAVAGE: Yeah, yeah, please.

R DEARMAN: Would the Cafcass report saying that they have a concern about Ella telling the kids stuff-

DC SAVAGE: I don't-

R DEARMAN: -and telling them what to say. I know that's to do with that-

DC SAVAGE: Yeah.

R DEARMAN: -but is this not, similar-

DC SAVAGE: No, look-

R DEARMAN: -does it not cross-over, let's say?

DC SAVAGE: The best way for me to do it sir, is if we start finishing off and I'll turn, and off tape-

R DEARMAN: Mm-hmm.

DC SAVAGE: -unless you want me to tell you on tape, it doesn't really matter. [Inaudible]-

R DEARMAN: And same with the -

DC SAVAGE: -[inaudible].

R DEARMAN: -video of her telling the kids how to be and what to say?

DC SAVAGE: What happens is, sir, the police and the Social Services-

R DEARMAN: Mmm.

DC SAVAGE: -have to work together-

R DEARMAN: Yeah.

DC SAVAGE: -right, so work together for the safe protection[?], safety of children in London, so we all work together-

R DEARMAN: Mm-hmm.

DC SAVAGE: -so, I, like I said, I came in, on to this matter last week, so I don't know much about it. I'm presuming, well I know for a fact DS Fernandez has been to every single meeting with Social Services-

R DEARMAN: Mm-hmm.

DC SAVAGE: -so I'm assuming information would be shared-

R DEARMAN: Mm-hmm.

DC SAVAGE: Does that make sense?

R DEARMAN: Oh, no it hasn't.

DC SAVAGE: Okay, okay. So basically all the information, we share information-

R DEARMAN: Okay.

DC SAVAGE: -so we share, so we tell them-

R DEARMAN: Okay.

DC SAVAGE: -about what's been going on.

R DEARMAN: Okay. The reason I'd say that they hasn't [sic], I could be wrong, I spoke with, and this was one of the reasons I wasn't happy with Social Services, I spoke with Yvonne and

Chantelle last week, I said, 'Guys, why did you not get the three, four years' reports-

DC SAVAGE: Mm-hmm.

R DEARMAN: -of the, this would give you, don't have to use it, it gives you a picture of what's gone on'-

DC SAVAGE: Mmm, Mmm.

R DEARMAN: -They don't have these reports from Cafcass-

DC SAVAGE: Okay.

R DEARMAN: -of this happening and that happening, why?

DC SAVAGE: Okay. Well, what I'll do is I'll-

R DEARMAN: They've started from scratch, and I would argue with Richie on the phone, 'Why start from scratch?' he said, 'Ricky, you can't kick about old stuff', I said, 'Courts have said this to me for five years'-

DC SAVAGE: Okay.

R DEARMAN: -and I let it go and it happens again.

DC SAVAGE: I-

R DEARMAN: They have data, they have written information of Ella doing this and saying this-

DC SAVAGE: Mmm.

R DEARMAN: -and being caught out lying and this and this and trying to stop the kids from seeing me and stuff-

DC SAVAGE: Right.

R DEARMAN: -it goes; they would've had a more...-

DC SAVAGE: Valid picture.

R DEARMAN: Yes.

DC SAVAGE: But, I'm going to stop you there-

R DEARMAN: Yes.

DC SAVAGE: -because obviously we are jumping again-

R DEARMAN: I know.

DC SAVAGE: -onto Family Court stuff. But I have put there, you can see, 'Chase Cafcass reports' and I will pass that on to-

R DEARMAN: Okay.

DC SAVAGE: -DC Martin and my Sergeant in charge of this case.

R DEARMAN: This is just [a mess?].

DC SAVAGE: If there's anything else you want to tell me about the offence that's been alleged-

R DEARMAN: Mmm.

DC SAVAGE: -I say alleged very strongly, please tell me, if not sir, I'm going to start, sort of, wrapping up because obviously, I think, we're going into a lot of Family Court territory here and I don't want this to, because this can be disclosed in Family Court-

R DEARMAN: Yes.

DC SAVAGE: -to sort of maybe-

R DEARMAN: Yeah.

DC SAVAGE: -cause you any problems, if I'm honest.

R DEARMAN: I'm just, just, I'm just, [had enough?], the, I'm just, trying to find words of the allegation and how it makes me feel, um, it's just all gone-

DC SAVAGE: I can see you're getting upset there sir, so I'm going to stop the interview now, sir. Not because you're upset but, obviously I think it's time to finish. I'll stop the interview at 17:26 on Monday the 15th of September 2014. Okay, sir.
