He said that 1st of all the dates that have been disclosed are in correct the first time he was allowed to see his children was after he had been to court to get a order to allow him to see his children. On the 5th of July 2014 he did take the children swimming; he thinks that it was the complex in Finchley, near the a406. They went in and choose a cubicle which was a big on he choose this as he had 2 children with him. He said in side the changing room was a bench and a fold down baby changer. They all wanted to use the pool with the wave machine but this was not working. So they played with a ball around the pool. After about 1hr they have got changed all together in the large changing room.

On the 2nd time they met up they all went to London on day out they got some food from Barents health shop, they then went on a river cruise. While on the cruise his daughter has said that when she was ill the mother BF has come in to her room and given her a hot lemon drink. While doing this he has pulled her hair.

On the same trip Gabriel disclosed.

His son told him that he has walked in on his muni and her BF having sex,

MR Demean thinks that this has been said because

1. His wife has been telling the children what to say he said that he has witness this via Skype.
2. the mother would like to leave the UK and move to Russia, which he has refused to allow.

He said that he feels that the police should look at the reports that the Cafcass have on the mother lying and failing to care for the children.

A further interview has been completed with the children and both have withdrawn their allegations, en-route to the interview the children discussed a film they had been watching called the mask of zorro and within the film that the children said someones head is chopped off, and I asked if it was anything like they had witnessed with the babies and they replied that this was where they got the idea from. I asked them to tell me about it more once we got to the station.

Upon arrival at the station Elicia was interviewed and she gave an account she stated that everything she had said about her father was untrue, she stated that she had been pressured into saying these things by Abraham whilst in Morocco. She stated this initiated when she was caught with her brother touching each other in a sexual way she told Abraham that she had learned this from another child called sophie who she had engaged with in a sexual way. Abraham declined to believe this and repeated a number of times who showed

you and persisted with this. He has then said that he knows who showed her and that it was her father she refuted this a number of times but eventually gave up and agreed that it was his father, she has been asked a number of other questions and is not believed by Abraham until she gives an answer that fits what he wasn't to hear. She went onto say that the reason she could not pick out what house the father lived at as he did not live in London and so just picked out any house as she felt pressure to do so, the idea about the room behind the wardrobe was also from the film mask of Zorro as was the idea about eating the babies as there is a part which they drink from water in which body parts are placed. She also stated that the idea of plastic penises was introduced by her and this was how her brother knew of these. She strongly dislikes Abraham and states that her mother just goes along with whatever he says. As for the injury to her ear she states this was from an infection a number of years ago. She states she has been hit by Abraham because of this which he did in morocco not in UK.
